PAYMENT

The emoluments may be paid by one of the following methods:

1) ATM available at the General Consulate facilities.

IMPORTANT NOTICE:

PLEASE BE SURE TO ORDER THE PROPER PAYMENT AMOUNT.
- **THE PAYMENT RECEIPT MUST BE ATTACHED TO THE REQUEST**
PLEASE KEEP A COPY OF THE RECEIPT.
- **INTERNATIONAL PAYMENTS MUST INCLUDE AN EXCHANGE FEE OF £2 FOR AMOUNTS UNDER £100, OR £7 FOR AMOUNTS OF £100 AND ABOVE.**
Example: normal ordinary visa returned by post: £100 (visa emolument) + £10 (mail cost – please see below) + £7 (exchange fee).

HOW TO APPLY

1) **At our office** at 21 Bedford Avenue, London WC1B 3AS. Our working hours are as follows:

– **Submission of documents**

– **Collection of documents**

Monday, wednesday and Friday, 14.00h to 15.00h.

If the applicant wishes to receive the documents by mail, please include a Royal Mail special delivery pre-paid and addressed envelope in order to ensure safe delivery. Alternatively, the applicant must pay ten pounds (£10) to cover mail costs, please also include proof of payment.

Please note: In choosing any other method of delivery, the applicant is responsible for ensuring that proper measures are taken. The Consulate General will not complete any forms from delivery services.

Please note: applications for some services such as Consular Registration, National Passport, Birth Registration, Wedding Process, must be submitted in person – Please check carefully the relevant requirements.
